Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.

In 2020-21, the Council made payments totalling £ _____ under section 137. These payments are included within 'Other payments' in the Accounting Statement.



Auditor General's report

Audit opinion - Qualified

Except for the matters reported in my Basis for Qualification below, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's/Committee's governance arrangements; and
- that the Council/Committee does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of qualification

Due to a limitation in the scope of my audit arising from the Council not providing information required for the audit, I am unable to conclude whether or not the accounting statement properly presents the Council's receipts and payments and financial position as at 31 March 2020:

- The Council did not provide a bank reconciliation to demonstrate that the accounting statement is a complete and accurate record of transactions and balances
- The Council did not provide an explanation of changes in receipts and payments compared with the prior year

In my opinion, the Council's governance statement is not consistent with the actual arrangements in place during the year.

- Assertion 1: The Council did not approve the accounts in accordance with the requirements of the Accounts and Audit (Wales) Regulations 2014
- Assertion 3 - The Council has not provided its Clerk with a written contract or a written statement of the specified terms of employment under S.1 of the Employment Rights Act 1996 (ERA) within two months of starting employment

Other matters arising and recommendations

There are no further matters I wish to draw to the Council's attention.


